


What?

Initiative to promote the dialogue and cooperation between EU and China on water resources, based on three pillars: Political, Business and Scientific;

When?

Officially launched at the margins of the 6th World Water Forum, Marseille, March **2012**







How

- A Joint Statement was signed between the Minister of Water Resources and the European Presidency of the Council (DK);
- Main goal = achieve good governance of water resources;
- Enhancing mutual understanding between China and Europe on approaches in IWRM policy developments and implementation;
- Promoting exchange of innovative knowledge and technologies;
- Exchanging experiences and best practices;
- Creating opportunities for Chinese and European private sector;

 - Research Institutes
 - Municipalities
 - NGOs
 - Private Sector





Joint Steering Committee

- JSC is the highest decision-making body of the CEWP
- Members are the representatives nominated by the competent Ministries of the EU Members States and by the Ministry of Water Resources from China

High Level Dialogue Conferences

- 8 High Level Meetings took place till now
- Last one in January 2021, organised virtually
- Meetings occurs, one per year, with Europe and China alternating its organization

Secretariats

- Chinese Co-Secretariat is assumed by the Ministry of Water Resources
- The European Co-Secretariat is assumed by an EU Member States, in a rotating basis. Portugal (MECA) has this responsibility since 2020

EU Coordination Meetings

• To guarantee the full involvement of EU MS, to share information and to coordinate common positions, EU Coordination Meetings are organized, with the participation of the Commission (DG ENV) and the EU Del in Beijing. Last one 8th of September
