





# Implementing IWRM in the territories – A case study in the Senegal River Basin


A case study in the frame of the Cooperation between the Senegal river basin organization (OMVS) and the Adour-Garonne Water Agency (Agence de l'eau Adour-Garonne)

#### Background – IWRM in the Senegal River Basin

- Since 1972, a basin organization for the Senegal river basin: the OMVS
  - Transboundary, crossing 4 countries: Guinea, Mali, Mauritania and Senegal
  - 5 institutional contexts: in the 4 countries AND in the Senegal River Basin
  - Responsible for multiple use of the Senegal water: agriculture, access to drinkable water, navigation, hydroelectrical energy, etc.
- A basin governance that seeks inclusivity
- For inhabitants of the basin: a big area to apprehend, a lack of knowledge of the OMVS
- A dynamic basin: a lot of different initiatives and projects
- A collective of NGOs, implementing projects for more than 30 years in the area: the Senegal River Initiative (Initiative Fleuve Sénégal)

## Background – IWRM in the Adour-Garonne basin (France)

- Water and sanitation management at the basin level through Water Agencies and their Basin Committees
- Creation in 1964 of the Adour-Garonne Water Agency (Agence de l'eau Adour-Garonne)
- IWRM dialogue frameworks and tools adapted to the context
- A rural basin with many agricultural users, a lot of stakes around water pollution, droughts and floods



### Since 2002, a cooperation between two river basins: Adour-Garonne and Senegal

- Working together on **governance** issues, leading also to **technical partnerships** to work on Water Information Systems, satellites data exploitation, etc.
- Making resilience/adaptation to climate change a spine to all activities
- Considering water resources in articulation with the services
- A partnership that opens itself to other stakeholders at different scales (particularly the field level), and notably the decentralized and non-governmental actors (in link with the French Water Solidarity Program)
- A big incentive to mobilize local collectivities on IWRM



#### The stakes of IWRM in the Senegal River Basin

- Climate change: salinization of the fields, droughts and floods, etc.
- Improving access to water and sanitation
- Water **pollution**: gold mining, invasive plants, agrochemicals, etc.
- Difficulties to implement IWRM strategies in the territories (top-down)
- Legal framework stakes for the articulation of all 4 countries PLUS the river basin legal framework

## The case study: creating a multi-actor framework dialogue to develop IWRM

- Since 2018, an annual meeting of the actors of the Senegal River Basin in link with the Adour Garonne/French actors, including: cooperation actors and donors, local authorities of the basin, universities, research organizations, the civil society and NGOs.
- At first, an initiative held with the support of the French Water Solidarity Program, then retroceded to the **Senegal River Initiative** (with a power of action in the field) that holds the meetings since 2020.
- Cooperation between 4 southern countries and a northern one (France): sharing experiences and good practices in the 5 countries to build a dialogue framework adapted to the Senegal River Basin,

#### Impacts aligned with global goals and SDGs - 1

- Environmental sensitizing and action taking in link with water resources management and water and sanitation access
- A key tool for peace building in the region
- An incentive for transboundary cooperation: beyond the institutional frontiers, water gathers. Building a feeling of belonging to the basin between the actors
- Bottom-upping the IWRM, making needs and demands match the IWRM institutional frameworks
- Articulating basin level Cooperation with decentralized cooperation >> a tool to build capacities and to provide funds
- Thinking about new ways of funding the initiatives in favor of water management in the area: working on fiscality, taxes on payments, etc.

#### Impacts aligned with global goals and SDGs - 2

- **Distinctiveness of the partnership**: multi-actors/partnerships/countries initiative
- The dialogue framework contributes to the global thinking on IWRM and water governance (following OECD principles)
- Feeding the global goals with experiences aligned with the SDGs and the Blue Deal (Dakar declaration from 2022 World Water Forum).
- Feeding the international basin network organization with new initiatives and feedbacks
- Giving birth to new projects at the field level
