- There should be a “renaissance” of learned society journals like WI and particularly against the new megapublishers. This implies that the links between IWRA and WI could be re-emphasised and promoted as a strength of the journal going forward (many scholars seem to see WI as just one journal among many, which is wrong in my view).
- The editorial and review model used by WI should be celebrated as its use of extensive AE internal review mitigates the growing pressure on reviewers for “junk” reviews (coming especially from predatory publishers). IMHO it is a great model that reduces external reviewer burden AND results in a higher standard of curated content in the journal itself.
