LETTER FROM THE PRESIDENT



Dear members, friends and colleagues,

This edition of IWRA Update brings news of several important upcoming activities, notably the IWRA Executive Board elections, the next World Water Congress and the development of ever more regional

activities and publications. Over the last few months, IWRA has also been busy participating in and developing activities around the world. The 6th World Water Forum in Marseilles on March 12-17 was a busy time with IWRA leading several sessions on water quality, water accounting and the science-policy interface; as well as co-sponsoring many other sessions. As one of the key international supporting Associations, IWRA participated in the ASIA 2012 Conference on 26-27 March of 2012, Chiang Mai, Thailand - where we made contributions regarding water resources and renewable energy development in Asia. Recently, IWRA also participated in the BALWOIS conference in the Balkan region where we are seeking to develop regional activities and build local partnerships. Regarding our own World Water Congress, the Executive Office has re-launched a call for candidatures to host the 15th IWRA World Water Congress. This follows the cancellation of the previous announcement

to host it in Granada, Spain due to a mutual inability to reach an agreement.We are expecting to announce the new host in August/September this year. Other upcoming events involving IWRA stretch from South America with Rio+20; to Europe with the Stockholm International Water Week and HydroPredict 2012; to river symposiums in Asia and Oceania. I encourage you to contribute to IWRA's mission at these events or others in order to connect knowledge, policy and management for our water resources.

Finally, and as you know, the IWRA Executive Board mandate runs for three years and the current board will maintain active duty until the end of this year. The call for elections for the 20130-2015 IWRA Executive Board is announced in this newsletter, on the IWRA website and also in May's edition of Water International. I am pleased and honoured to announce 25 outstanding candidates from 18 different countries. The Executive Office will shortly be contacting all members regarding ballot papers, I strongly encourage you to vote and participate in the good governance of our association – your voice counts!

6th World Water Forum

IWRA was actively involved in the recent World Water Forum in Marseilles, France from 12 to 17 March. The association co-organised several sessions and panel, discussions;

and held displays at our partner's booths (Taylor&Francis, UNWater and Montpellier water community at the French Pavilion) in the exhibition hall during the Forum.

Technical sessions within the framework of the thematic process organised by IWRA during the Forum:



Session 2.1.3: Which water quality for which use?

«By 2015 establish a worldwide recognised frame of reference related to the quantity and the quality required for different uses, through joint work between international professional associations representing all usages of water and scientists.»

Mr. Tom Soo, IWRA Executive Director, coordinated the session with the able co-coordination of Mr. Dominique Gatel, EUREAU. The Target and Solution group of this target produced a stock-taking report which gathers existing guidelines on water quality regarding different applications, illustrated by international, national and regional frames of references on water quality.

A commitment was taken together with UNEP in order to complete a compendium with the aim of establishing an international frame of reference related to the quality required for different uses of water for the upcoming 7th World Water Forum, in 2015.



Session 2.1.7: Water accounting & management for balancing multiple uses of water.

«By 2015, IWRM authorities, jointly with water service professionals will identify reliable methods and provide recommendations on appropriate equipment for accounting/ measurement of withdrawn water resources as well as produced, distributed, consumptive use and return flow water volumes. As part of this process, international organisations will develop recommendations regarding which water related information should be retained or shared.»

The session was coordinator by Prof. Jun Xia, IWRA President.

IWRA was also coordinating a High Level Panel on «Science, Technology and Policy for Better Water Governance».

This High Level Panel brought together leading political personalities and representatives of international scientific and technical NGO's from around the world. The panel discussed the roles of science, technology and policy in enabling the environment for good water governance.




Special session: IWRA supported a special session on the FUTURE OF WORLD'S WATER IN 2025 AND BEYOND.




Agreement signed between IWRA and AIDA

IWRA visits China

In early June, President Jun Xia and Executive Director,

Tom Soo visited Beijing, China to meet with the Ministry of Water Resources and to develop activities with the IWRA China Committee. The meetings reaffirmed the importance of mutual cooperation on international water issues and China's capacity to make technical contributions to the global water dialogue. Tom went on to visit Qingdao in Shangdong province to discuss ideas for a regional activity later this year with the Qingdao Hydrology and Water Resources Survey Bureau. Meetings were also held with the Yellow River Commission in Zhengzhou regarding collaboration on the Yellow River Forum where IWRA is a supporting organisation.

YOUTH INFUSION IN WATER INTERNATIONAL EDITORIAL STAFF

Philippus (Flip) Wester was appointed to the new position of Deputy Editor-in-Chief of *Water International*, as of March 2012. He is now primarily responsible for handling individual submissions, which should be sent to him at **iwrawin@gmail.com** until we convert to an

on-line system later this year. Other matters, including special issue proposals, should be sent to the Editor-in-Chief, James E. Nickum, at iwrapubs@gmail.com.

Since 2009, *Water International* (WI) has increased in frequency from four issues a year to seven, individual submissions have increased by half, and special issues have come to play a dominant role. The purpose of establishing a Deputy Editor-in-Chief position is to spread the workload, freeing the Editor-in-Chief to focus on special issues, and to work more to extend the reach and impact of WI and related IWRA publications, such as a book series. It will also allow us to further improve the quality and efficiency with which we handle individual submissions, without losing our personal touch. With the appointment of Flip and his replacement as Associate Editor by Naho Muramachi (see below), the editorial staff has taken on a much younger look, with half under the age of 50.

Flip was previously an Associate Editor of the journal since January 2010 and was also a member of the International Scientific Committee of IWRA's XIVth World Water Congress. He is assistant professor of water reforms at Wageningen University (http://www.iwe.wur.nl/UK/Staff/Wester/). In his research and teaching he focuses on the politics and governance of water resources, river basin management, water reform and allocation processes, water governance in deltas, participatory groundwater management and irrigation water management. Trained as an interdisciplinary sociotechnical water researcher with a strong grounding in the social sciences, he has over 18 years of professional experience, in which he has developed a thorough understanding of the interrelationships between the social, technical, political and physical dimensions of water governance. He has designed

and executed interdisciplinary water governance research projects in Senegal, Pakistan, Bangladesh, Mexico, Ethiopia and the Netherlands and has published some 50 articles and book chapters.

Flip combines teaching and research with capacity building, most recently as overall project director for the Nuffic NICHE project on Capacity Building for IWRM in South Africa and as Wageningen University project coordinator for the Nuffic project Strengthening Ethiopian Universities in Integrated River Basin Management. At Wageningen University he has played a strong role in the development of the BSc and MSc International Land and Water Management (ILWM) education programme and from January 2008 to September 2009 served as the Secretary of the Education Programme Committee ILWM.



Flip's replacement as Associate Editor is **Dr. Naho Mirumachi**. Dr. Mirumachi is Lecturer at the Department of Geography, King's College London. She has multidisciplinary training in International Relations, International Studies and Human Geography. Her main

research interest focuses on the politics of water resources management. Through empirical analysis of developing country contexts, she examines three inter-related themes: institutions of water allocation; power and environmental discourse; and scale and agency. Her main fieldwork experiences are in the Orange-Senqu River basin in Southern Africa, Ganges River basin in South Asia, and the Mekong River basin in Southeast Asia. Naho is dedicated to communicating between science and policy and currently convenes the MSc Water: Science and Governance programme at King's College, and is involved in training policy-makers on water security.



IWRA (India) Journal


The Indian Geographical Committee of IWRA has taken the initiative to publish "IWRA (India) Journal", on half yearly basis (January – June and July-December).
