Letter from the President

IWRA Actions in 2010 & Perspectives for 2011-2012



2010 was the first year for the new IWRA
Executive Board (2010-2012). There are a lot of opportunities and challenges for the IWRA board and IWRA members. I would like to express my appreciation to the

IWRA Board, the Executive Office in Montpellier and IWRA members all over the world for your support and contributions to IWRA's international activities and profile. These efforts have resulted in significant advances in 2010.

Firstly, I would like to note that the IWRA Executive Office was moved to Montpellier, France in April, 2010. This represented a big leap towards making IWRA's actions workable and stable. I would like to thank Mr. Tom Soo, our new Executive Director and the office staff who have worked very well on critical IWRA activities such as this newsletter, organising IWRA Board meetings and international actions and financing. I also thank our Treasurer, Prof.

Gabriel Eckstein, and the Chairs of our various Committees, Prof. Shi Guoqing (Membership), Prof. Christopher Scott (Publications) and Prof. Victor Dukhovny (Awards) for their outstanding work. A warm thank you is also extended to Association VERSeau Développement, the Région Languedoc-Roussillon, the Département de l'Hérault in France, and to Promar Consulting in Japan, for the support given to the daily operations of our Association.

Last year, IWRA held two Board meetings: in Montpellier, France on 5-7 June, and in Nanjing China on 20-21 November. We discussed many key issues regarding IWRA activities, made plans and took decisions on how to improve the association's external and internal actions including our finances.

Throughout 2010, IWRA was an active member of the Board of Governors of the World Water Council (WWC). In the coming years we aim to play a key role in the development of WWC strategies and actions. This includes work on themes such as integrating Water Supply Management and Water Demand Management

(WSM & WDM), Multiple Uses of Water (MUW), trans-boundary issues and water governance. IWRA participated in all of the WWC Governor's board meetings in 2010, and collaborated with the WWC's actions during the Shanghai World Expo 2010. IWRA has also been involved in the preparatory committees and some of the Core Groups and Target and Solution Groups for the 6th World Water Forum that will be held in Marseille. France in 2012.

In 2010, IWRA also strengthened and built cooperation & linkages with other international water communities, such as becoming a partner of UN Water and working with the United Nations Environment Programme (UNEP), the World Water Assessment Programme (WWAP), the Singapore International Water Week organised by the national water agency (PUB), the Stockholm Water Week organised by the Stockholm International Water Institute (SIWI), the Inter Academy Council (IAC) Water Programme, Global Water System Project (GWSP), Inter Academy Panel (IAP) Water Study, Think Tank on Water and the Future supported by the Calouste Gulbenkian Foundation, Hydropower & Dams, and Aqua~Media International Ltd, amongst others. IWRA looks forward to building more partnerships with international water programmes and increasing our actions on organising international Congresses, symposiums and workshops on global and regional levels. In this sense I would like to thank the entire IWRA Executive Board for the considerable contributions made to the association. In particular, I appreciate the continuity provided by IWRA's past President, Prof. Cecilia Tortajada, who built a solid foundation for the association and has given me very helpful suggestions and support.

Our Association's journal, Water International, has made significant advances under the hard work of the Editor-in-Chief, Prof. James Nickum, the Editorial Board and the Publications Committee headed by Prof. Christopher Scott, as well as the professional staff at Taylor & Francis (Routledge). The impact factor is increasing, as is the number and quality of manuscript submissions. The number of issues per year has increased from four to six in 2010 and again to seven this year, and there has been a significant increase in cutting-edge special issues, many of them produced in cooperation with international research organisations such as Consultative Group on International Agricultural Research (CGIAR) and International Water Management Institute (IWMI). Water International continues to maintain and develop its position as a truly international water journal that reflects the IWRA network and its commitment to exploring issues of water governance, water policy and water strategies across national and disciplinary boundaries.

Strengthening regional IWRA actions will be increasingly important as we move forward. During 2010, several regional activities were undertaken such as ASIA2010 in Malaysia and STAHY2010 in Italy as well as closer engagement with IWRA's national committees in Japan, India and China. Another exciting development from 2010 was the signing of an agreement with the Qingdao Bureau of Hydrology to jointly operate the "IWRA-China Qingdao Science-Technology & Education Centre for Water Resources". The local sponsor, the Qingdao Bureau of Hydrology, will provide this centre with basic facilities, the building and help to organise international academic exchanges. This is a new start for IWRA

regarding building regional networks of Science, Technology & Education on water resources. I do hope that similar initiatives and the fostering of IWRA regional/national committees can be encouraged in other regions around the world.

The 14th IWRA World Water Congress with the theme of Adaptive Water Management: Looking to the Future will be held during September 25-29, 2011 in Porto de Galinhas, Brazil. This is IWRA's most important international action in 2011. I would like in particular to thank the Chair of International Scientific Committee (ISC), Prof. Christopher Scott and the various distinguished members of the ISC, Prof. Rui

IWRA Celebrates World Water Day

World Water Day was held on 22 March this year with the

theme of "Water for Cities: Responding to the Urban Challenge".

Multiple events were co-organised between UN-HABITAT, UN-Water and The African Ministers' Council on Water (AMCOW) in Capetown, South Africa. As Vice-President of IWRA, Anthony Turton sat on a panel convened by the World Bank on the topic of Public Private Partnerships. He also gave a speech at the opening of the Water Institute at the University of Stellenbosch. Anthony tells us that the Water Institute Head, Prof. Eugene Cloete, "has just invented a nanofilter that can remove toxins from water in what can best be described as a "tea bag"".

Also on World Water Day (22 March 2011), the Secretariat of the Indian Geographical Committee of IWRA and the

Central Board of Irrigation & Power (CBIP) organised a Seminar called "Narmada – The Lifeline" in association with Sardar Sarovar Narmada Nigam Limited, as part of the Diamond Jubilee Celebrations of the formation of the State of the Gujarat in India.

IWRA was a knowledge partner in this event and the seminar focused on issues such as Safe Drinking Water – A Human Right, Innovative Approaches in Water Management, Legislative /Regulatory Framework in Water Sector besides the Role of Sardar Sarovar Project (SSP) in Longterm Water and Energy Security.





IWRA Board Director and member, Prof. Viktor A. Dukhovny has published a book with Joop L. G. de Schutter titled *Water of Central Asia: Past, Present and Future* and published by CRC Press.

Synopsis



Central Asia is the cluster of countries located in the basin of the "Great Aral Sea". It originates from the ancient civilizations of the IVmillennium B.C. known as "Ariana" and is an important geopolitical centre today, where the USA, Russia, China, EU, Iran and India participate in the regional

water game. The Aral Sea Basin has always been a subject of interest to outside powers as a target of travel or political blame. At the same time it was a source of prosperity and a place of work, love, history and strong cultural traditions for almost 100 million people. At present the Aral Sea Basin is shared by independent states with different interests but at the same time in need of close collaboration for their survival. Much has been written about this region but few writers have discovered the deeper roots of the historical trans-

formations that have caused the present situation of environmental degradation. The extremely arid character of the region is a cause of very sensitive natural and social conditions; a very fragile balance that is easily disturbed by any important impact from the outside or innovations from the inside. Only a thorough analysis of both the positive ambitions of the region and their possible negative consequences can provide the necessary understanding of why important development initiatives of the recent past have always produced the negative consequences as they did.

Continuing with our regular newsletter series on member perspectives, in this issue, we meet Prof. Bruce Mitchell, who became member in the early 1990s and was elected as fellow member in 2005. He was also a Director of the Executive Board from 2004 to 2006.



Interview with Bruce Mitchell

What are your main fields of interest in Water Resources? Tell us about some projects you are currently involved with.

B.M.: My main focus is water policy and governance, with attention to improving the transition from visions and plans to effective implementation. These interests have been pursued with regard to "integrated water resource management" through projects in Canada, Australia, China, Indonesia and Nigeria.

I now am involved in the first stage of a project focused on assessing opportunities for a healthy urban ecosystem in Shenyang, China, for which my contribution will relate to water security.

I am a member of the recently created Water Institute at the University of Waterloo, which has more than 100 faculty members conducting research on a wide range of water issues. The Institute is facilitating interdisciplinary research connecting science, technology, management and governance aspects of water.

Why did you join IWRA and what does membership of IWRA's international network mean to you?

B.M.: I was actively engaged in a number of international water projects, and believed that membership would help me to become better informed about activities by others, and also to broaden my network of colleagues. Both have occurred, and thus for me there has been real value in being a member.

How do you see IWRA's role in today's water management scene?

B.M.: IWRA has a role to encourage and facilitate interdisciplinary understanding of water resources through its publications (journal, newsletter), conferences and workshops. It also has impact through partnering with other water-oriented organizations to promote awareness of water issues and opportunities. Furthermore, it helps to inform and educate various target groups, ranging from researchers, government public servants, consultants, and individuals in both community-based organizations and the private sector.

In memoriam

Professor John Pigram (1934 -2011)



Former IWRA President Professor John J. Pigram, from the University of New England in Armidale, Australia, has passed away on January 5, 2011 at the age of 77 after a long and distinguished career. Professor Pi-

gram has made many outstanding contributions to the field of water policy, provided exceptional academic leadership in water resource management and water reform in Australia and other regions of the world. His achievements are recognised and appreciated by the IWRA global community of water professionals.

In 1987, in cooperation with two Australian colleagues, Professor Warren Musgrave and Professor John Burton, Dr Pigram jointly established the Centre for Water Policy Research at the University of New England where he served as Executive Director and Director until 2001. Dr Pigram had supervised more than 50 graduate students at the Doctoral and Masters levels, many of whom are now active in the application of water policy initiatives and water reform in Australia and elsewhere.

Dr Pigram has been published widely and also made numerous presentations on critical aspects of water policy. He provided important insights into the issues of water allocation, property rights and water markets (including third party effects), the value of water, economic instruments and water demand, integrated approaches to water management, ecological impacts of water development, and the essential elements for formulating a

framework for water policy. Most recently, his attention had been drawn to international cooperation and the transfer of information, experience and expertise in water management between diverse world regions and different countries.

In the international sphere, Dr. Pigram was a strong supporter of the World Water Council, the Global Water Partnership, and other organisations involved in the formulation and implementation of water policy initiatives globally. He served as Chair of the IWRA Xth World Water Congress in Melbourne in 2000 and was elected to prestigious positions in international water organizations. He was Director and Vice-President of the International Water Resources Association before becoming President in 2000 and a Fellow of the Association in 2005. He was honored to be the recipient of IWRA Ven Te Chow memorial Lecture in 2008. He was a Founding Member of the Board of Governors of the World Water Council in 1996 and continued on the Board until 2006. Professor Pigram has served as an invited Member of the Club of Tokyo, a small group of influential persons in the world of water, and was also on the Editorial Board of leading international water resources journals. He recently authored an outstanding text book on water resources in Australia.

In all his dealings Prof Pigram displayed a high degree of integrity, honesty and straight forwardness matched only by a few. He will be missed by all, may his soul rest in eternal peace.
